- the skull and crossbones, the exclamation mark pictogram should not be added.
- corrosive effect, the exclamation mark pictogram should not be added if it concerns eye or skin irritation.
- health hazard determining respiratory sensitization, the exclamation mark pictogram should not be added if it concerns skin sensitization or irritation to eyes or skin.
